

HOLLOWELL SAILING CLUB – DATA PRIVACY POLICY

1. About this Policy

1.1 This policy explains when and why we collect personal information, how we use it and how we keep it secure, and your rights in relation to it.

1.2 We may collect, use and store your personal data, as described in this Data Privacy Policy and as described when we collect data from you.

1.3 We may update this policy from time to time to reflect changes in legislation or Club operations. Any updates will be posted on our website and Club noticeboard, but will not be applied retrospectively.

1.4 We will always comply with the General Data Protection Regulation (GDPR) when dealing with your personal data. Further details on the GDPR can be found at the website for the Information Commissioner (www.ico.org.uk). For the purposes of the GDPR, we will be the "controller" of all personal data we hold about you.

2. Who are we?

3. What information we collect and why

4. How we protect your personal data

4.1 We will not transfer your personal data outside the EEA without your consent.

4.2 We have implemented generally accepted standards of technology and operational security to protect personal data from loss, misuse, or unauthorised alteration or destruction.

4.3 While we take all reasonable steps to protect your data, please note that data transmission over the internet can never be guaranteed to be completely secure.

4.4 For any payments we take online we use a recognised secure payment system.

5. Who else has access to your information?

5.1 We will never sell your personal data. We will not share your personal data with any third parties without your prior consent except where required to do so by law, or as set out above.

5.2 We may share data with service providers working on our behalf (e.g. for printing or IT). They are required to keep your data secure and not to use it for their own purposes.

6. How long do we keep your information?

6.1 We retain personal data for as long as necessary to manage your membership and Club activities. After this period, data may be archived to meet legal or legitimate purposes such as rejoining records or tax obligations.

6.2 We review our records annually and securely delete or anonymise data no longer needed.

6.3 We securely destroy all financial information once used and no longer required.

7. Your rights

7.1 You have rights under the GDPR:

- To access your personal data
- To be informed about how your data is used
- To correct any inaccuracies

- To request deletion of your data
- To restrict or object to certain processing
- To request your data be transferred to you or another organisation
